Sub: Dr.YSRHU – Academic – Implementation of the Gazette notification issued by the Anadhra Pradesh Government regarding the fixation of fee for Affiliated B.Sc. (Hons.) Horticultural colleges for the block period of three years of 2023-24 to 2025-26 - Information communicated.

With reference (1st) cited above, the Andhra Pradesh Government has issued a gazette notification regarding the fixation of fee for convener quota seats in Affiliated B.Sc. (Hons.) Horticultural Colleges for the block period of 2023-24 to 2025-26.

In this context, all the Associate Deans of affiliated Horticultural Colleges are hereby notified that the following fee structure has been implemented by the University.

Hence, all the Associate Deans of affiliated Horticultural Colleges are hereby instructed to follow the above fee structure for the block period of three years i.e., 2023-24 to 2025-26 with the following instructions with out any deviation and requested to remit the University share to the Comptrollers account with in the stipulated time.

a) The fee is an all-inclusive annual fee including various fee like tuition fee, affiliation fee, stipend, admission fee, registration fee, cost of identity card, medical fee, inter college/inter-univerity sports, games & cultural meet fee, laboratory fee, library fee, computer/internet fee, College magazine, and student activities, student health care scheme, student welfare fund, study tour, alumni fund, sports and games fee, examination fee including stationery, maintenance and amenities fee, extracurricular activities fee, development fee, and other recurring expenditure.

- b) The aforesaid fee determined for the agricultureal and horticultural courses for the colleges mentioned in ANNEXURES-I & II for the Convener Quota doest not include hostel, transport, mess charges etc.
- c) The institution shall collect the annual fee for every year in two half-yearly installments at the time of Semester Registration.
- d) The same fee shall continue for the students admitted during the block period of 2023-24 to 2025-26 till they complete the programme.
- e) The institution shall not charge either directly or indirectly any other amount over and above the fee fixed in the Annexures. If any other amount is charged under any other head or guise i.e., donations, the same would amount to charging capitation fee and are liable to be prosecuted under Section 9 of Act 5 of 1983 apart from imposing appropriate penalty under the APHERMC Act, 2019 and the APHERMC Rules, 2019.
- f) Stipend shall be paid to the students on par with the students in the University/Government Colleges till the institutions get accreditation from the ICAR.
- g) In case of any deviation from these directions, the Commission will initiate action entailing serious penal consequences as per the Act and Rules made thereunder.
